Since the beginning of June, the companies have continued their activities under new names: **Admatec Additive Solutions B.V.** and **Formatec Advanced Products B.V.** This preserves almost thirty years of accumulated expertise in technical ceramics – and lays a strong foundation for a stable, innovative future.

Almost thirty years of technological development in ceramics

Formatec was founded in 1996 and has grown into a specialist in high-quality Ceramic Injection Moulding (CIM). In 2012, Admatec was founded as a pioneer in the development of industrial 3D printing technology (Additive Manufacturing) for ceramics and metals. Admatec has built up a global customer base, with a particularly strong installed base in the United States, where their technology is widely used in the semiconductor industry, aerospace and medical applications, among others.

In recent years, the companies have been part of a larger international technology holding company, in which – despite strategic ambitions – the attention for the Dutch operation gradually faded into the background. The restart therefore marks a conscious change of course: back to local anchoring, direct management and long-term focus, with full dedication to the preservation and further development of the technological core.

New shareholders with a long-term vision

The new course is supported by Michiel de Bruijcker, together with two Dutch investors with extensive experience in industrial technology and sustainable companies. Their focus is explicitly on long-term value creation, knowledge retention and high-quality employment in the region. This combination of entrepreneurship, technical expertise and financial stability forms the foundation for the restart.

Crucial to the success of the restart is the preservation of knowledge, production capacity and customer relationships. The companies continue to operate with their experienced teams, infrastructure, and technologies. This allows them to continue to serve customers worldwide with innovative custom solutions of the highest quality.
